

Visalia Police Foundation 30 Guns in 30 Days Raffle Official Rules



- 1. Limit of 1000 tickets will be sold; numbering 000 to 999.
- 2. Cost is \$50/ticket. No limit to the number of tickets you may purchase.
- 3. All prizes are new, factory made firearms.
- 4. By obtaining a raffle ticket (either by purchase or as a gift) you attest that you are a law-abiding citizen of good moral character, may legally possess the firearm(s) won, have intention of using the firearm(s) only in a legal and safe manner, and will or have already obtained instruction on the safe use and operation of the firearm(s) won.
- 5. Daily drawings to start on May 1st, 2018 and continue daily for 30 days.
- 6. Raffles conducted on the weekends (Saturday & Sunday) will include the option of either a Rostered or (1) Off-Roster (Law Enforcement Only) Firearm. If a LEO wins the raffle, they may choose which firearm they want otherwise the rostered firearm will be the gun of the day.
- 7. Each day's winning number is obtained from the California Daily 3 Midday Lottery drawing of that day.
- 8. Winning ticket numbers are eligible for the remaining drawings.
- 9. All sold or unsold 1,000 ticket numbers are in each drawing. No prizes will be awarded on unsold ticket numbers drawn. In the event an unsold ticket is drawn at the midday pick, the number draw will move to the evening pick. If an unsold number is again not picked, no gun will be raffled for that day.
- 10. All firearms won are subject to availability and the Visalia Police Officer's Foundation (VPOF) reserves the right to make substitutions of equal or greater value.
- 11. Winning ticket numbers and firearm won will be posted on visaliapolicefoundation.org. To protect the winner's identity, the winning names will not be posted.
- 12. All proceeds to benefit the VPOF 501(c)(3). Please contact us at admin@vpoa.org if you have any questions or you lose a ticket.
- 13. You must be at least 18 years old and a legal resident of the United States to purchase a ticket.
- 14. Winner is responsible for all fees associated with any background check required to take possession of their prize.
- 15. This drawing by chance is conducted under California Penal Code 320.5. Raffle is void where prohibited.
- 16. It is the sole responsibility for the winning ticket holder to contact Morris Levin & Son Firearms in Tulare, Ca to claim their prize. Winner must present ticket to claim prize. ALL PRIZES MUST BE CLAIMED, AND TRANSFER COMPLETED WITHIN 60 DAYS OF THE SCHEDULED DATE THE TICKET IS DRAWN.
- 17. All Federal Bureau of Alcohol Tobacco and Firearms (BATF) rules apply.
- 18. Winners will be responsible for any applicable Federal, State and local taxes.
- 19. Transfers will be done by Morris Levin & Son Firearms. The VPOF solely reserves the right to change the location and/or dealer for any transfer. Winning ticket holder must make transfer through the VPOF selected dealer, and in accordance with all applicable laws.
- 20. Out of area winners have the option of having their prize transferred to their local FFL dealer for delivery. All firearm transfers will be done through a Federal Firearms Licensed (FFL) dealer, and all applicable Federal and State laws will apply, including the state laws for the legal residence of winning ticket holder. Winner is responsible for all shipping and transfer fees.

- 21. In the event winners need or wish to have the firearm(s) won transferred to another FFL dealer closer to their residence, shipping and any other additional costs involved with the transfer will be the responsibility of winner, and arrangements must be made directly with Morris Levin & Son Firearms.
- 22. Winners may be required to verify that ownership of the firearm(s) won is legal in their state, city or town, prior to taking possession of won prize(s).
- 23. At no time will the VPOF take possession of any of the firearms involved in this raffle; winners will receive firearms directly from Morris Levin & Son Firearms and all applicable laws will apply.
- 24. By purchasing raffle ticket, you agree that the VPOF's liability is limited to the purchase price of the raffle ticket.
